SPAIN

I. Objective:

The development and use of military facilities in Spanish territory for the common defense of the West, including the retention of existing rights as well as the re-negotiation of such rights as required in 1963-4.

A. Seek to develop and maintain the cooperative atmosphere within the Spanish Government necessary to achieve this objective.

MSP Courses of Action:

1. Provide economic assistance as outlined at I.B.
2. Provide the minimum military assistance necessary to achieve the above objective. Such assistance should take into account the political importance of the Spanish military establishment, particularly the Army, and the need for maintaining the cooperation of the Spanish military in the use of joint bases and facilities.
3. To the extent possible, such assistance should be responsive to priorities for specific equipment established by Spanish military authorities, and may include advanced weapons systems if these become politically necessary to achieve the above objective.

ETHIOPIA

III. Objective:

To assure access by the United States to military facilities in Ethiopia and continued use of the communications installation at Kagnew Station, Asmara.

A. Encourage Ethiopian orientation toward the West by demonstrating interest in cooperating with Ethiopia in meeting its reasonable military requirements.

MSP Courses of Action:

1. Provide military assistance to the Ethiopian Armed forces to the extent necessary for the attainment of this objective bearing in mind the limitations set forth in I.D.1. and 2.
2. Provide training to improve maintenance and effective use of military equipment and to orient key personnel.

INDONESIA

- I. A. 7. Maintain and strengthen existing U.S. ties with the Indonesian police and military establishments and increase their capability to maintain internal security by providing appropriate arms, equipment and training as follows:
- a. Expand U.S. training of personnel of the Indonesian armed forces to the maximum extent practicable and seek to curtail Sino-Soviet bloc training programs.
  - b. Provide military assistance in the form of equipment for Indonesian armed forces on a limited but continuing basis with the primary objective of favorably influencing and strengthening U.S. ties with politically important elements in Indonesia to enable them to avoid becoming dependent on the Soviet Bloc for their military needs and to bolster their resolve to resist Communism.
  - c. Within military assistance provided pursuant to b. above, seek to improve the ability of the armed forces to maintain internal security and combat Communist activity. Encourage acceptance of advisors and technical assistance to improve utilization of equipment and provide advice and assistance to develop an effective counter-intelligence capability.

Section VII. Latin America

3. Tasks. (Applicable to all countries in this section. Not necessarily listed in order of priority.)

- a. Defend coastal sea communications.
- b. Protect Inter-American maritime routes.
- c. Defend military bases, ports, communication nets and other essential facilities.
- d. Defend areas of strategic importance located within the OAS "Security Zone" as outlined in the latest approved "General Military Plan for the Defense of the American Continent Against an Aggression by the Communist Soviet Bloc".
- e. Assist the United States in executing the tasks set forth in the Bilateral Military Plans and such other tasks as may be mutually acceptable.
- f. Counteract subversive espionage, sabotage and other similar activities.
- g. Maintain forces possessing sufficient standardization of doctrine, methods, and material as will increase the flexibility of their employment.
- h. Maintain a stable government oriented toward the United States.
- i. Provide logistic support for national forces.

Section V. Southeast Asia and the Far East

4. Requirements for Force Development. (Applicable to all or a majority of the countries in Section V. Not necessarily listed in order of priority.)

- a. Maintain and improve the effectiveness of existing forces.
- b. Improve training techniques and procedures.
- c. Reorganize and modernize selected forces.
- d. Improve logistic and combat support techniques and procedures.
- e. Improve communication facilities.
- f. Replace obsolete or obsolescent equipment.

5. Cambodia

a. Mission. Preserve and maintain the integrity of a free Cambodian government.

b. Tasks.

(1) Maintain and strengthen integrity of armed forces as the most effective and cohesive national instrument with which to promote the best interests of the Cambodian people.

(2) Tasks listed in Section V, paragraph 3, apply.
